1. Goa Chief Minister Pramod Sawant launches Grih Aadhaar Scheme and Chavath-e-Bazaar (Sept. 20, 2023)

Chief Minister Pramod Sawant launched the Griha Aadhaar scheme and Chavath-e-Bazaar to empower housewives in Goa by providing them with financial assistance.

An Overview of the News

- The objective of the Griha Aadhaar scheme is **to promote the financial** independence and well-being of housewives, recognize their contribution and improve their socio-economic status.
- The Griha Aadhaar initiative led by the Directorate of Women and Child Development is an important step towards women's empowerment.

Support and Delivery:

- **Number of beneficiaries:** 11,500 newly sanctioned orders were distributed across the state, of which 6,000 orders were allocated to North Goa, taking the total to 1.5 lakh women beneficiaries.
- **Training for self-reliance**: Women are provided free training in their respective Panchayats, covering essential skills related to packaging, selling and other relevant aspects of food items.
- **Annual Increment:** Griha Aadhaar beneficiaries have received financial assistance directly into their accounts on the same day, and the scheme also includes an annual increment for continued support.

- Chief Minister Sawant also launched the Chavath-e-Bazaar programme, part of the Swayampura Goa programme, which aims to empower local entrepreneurs through e-commerce.

An Overview of the News

Enhanced benefits under the scheme

- Maternity benefit for families of workers has been increased from Rs 1,000 to Rs 6,000.
- Compensation for natural death has been increased from Rs 50,000 to Rs 2 lakh.
- Compensation for accidental death has been increased from Rs 1 lakh to Rs 4 lakh.
- The scheme also promotes sports among children of workers, offering cash incentives for achievements in state-level and national-level tournaments and competitions.

Cash incentives are provided for achievements in state-level tournaments or competitions:

- Gold Rs 15,000
- Silver Rs 10,000
- Bronze Rs 8,000

The following incentives are given for exceptional performance at the national level:

- Gold Rs 30,000
- Silver Rs 20,000
- Bronze Rs 15,000

An Overview of the News

- **Pradhan Mantri Matsya Sampada Yojana:** This initiative has a budget of Rs 20,050 crore and aims to promote sustainable development in the fisheries and aquaculture sector.
- **EHP-Cura-I**: Parshottam Rupala, Union Minister of Fisheries, Animal Husbandry and Dairying, Government of India, appreciated CIBA scientists for developing EHP-Cura-I, a therapeutic solution to control EHP disease in shrimp. He urged to ensure its early availability to the farmers.

- Specific provisions of the scheme include supplementary nutrition for adolescent girls aged 15 to 19 years, additional dry food for pregnant women, and complete meals for severely malnourished children. Moderately malnourished children will get vitamin-rich Chhatua (roasted gram flour) and eggs.
- Odisha is the first state in India to make a dedicated nutrition budget for the financial year 2020-21.

- Apart from the 'Chief Minister Sampoorna Pushti Yojana', Chief Minister Naveen Patnaik also launched the '**Pada Pushti Yojana'** especially targeting children.
- The initiative aims to provide high-quality cooked food to children, especially those living in remote and tribal areas of Odisha.

5. PM Modi to launch PM Vishwakarma Scheme on Vishwakarma Jayanti in New Delhi (Sept. 16, 2023)

Prime Minister Narendra Modi will launch the "PM Vishwakarma" scheme at the India International Convention and Expo Center in Dwarka, New Delhi on September 17, 2023.

An Overview of the News

- "PM Vishwakarma" scheme aims to support traditional artisans and craftsmen.
- The Central Government will fully fund it with an allocation of Rs 13,000 crore.
- Artisans (Vishwakarma) can register free of cost through Common Service Centres.
- They will be given identity through PM Vishwakarma certificate and ID card.

- The scheme also includes a toolkit incentive of ₹15,000 along with offering **skill**
- upgradation, and primary and advanced training.
- Artisans will get access to collateral-free credit assistance with concessional interest rates.
- Incentives will be provided for digital transactions and marketing assistance.
- Eighteen traditional crafts like **carpentry**, **blacksmithing**, **goldsmithing**, **pottery**, and **tailoring** will be covered.

Vishwakarma Jayanti:

- It is a Hindu festival dedicated to the divine architect, Vishwakarma.
- The celebration includes not only engineers and architects but also **artisans**, **craftsmen**, **mechanics**, **blacksmiths**, **welders**, and **industrial workers**.
- Prayers are also offered for the smooth operation of machines and equipment.
- Vishwakarma Jayanti falls on 'Kanya Sankranti' of the Hindu calendar, usually between 16 and 18 September in the Gregorian calendar.
- The festival is also celebrated in **Nepal**, and **Haldia** in **West Bengal** is known for its **Vishwakarma Puja** celebrations.

6. Social welfare scheme "Kalaignar Magalir Urimai Thogai Thittam" to be launched by Tamil Nadu Government (Sept. 12, 2023)

Tamil Nadu government will provide monthly assistance of Rs 1,000 to more than 1 crore female family heads through Kalaignar Magalir Urimai Thogai Thittam.

An Overview of the News

- Chief Minister MK Stalin officially announced the scheme, with the **launch date set for September 15.**
- The scheme aims to provide Rs 1,000 per month to 1.06 crore eligible women who are heads of families.
- Beneficiaries will receive financial assistance through direct bank transfers and will be provided with ATM cards for easy access.
- The government emphasizes on effective implementation and will use SMS notifications to communicate with beneficiaries.
- Out of 1.63 crore applications received, 1.06 crore have been accepted, highlighting the substantial impact of the scheme.

9. ASI to unveil 'Adopt a Heritage 2.0' program, Indian Heritage App and epermission portal (Sept. 3, 2023)

The Archaeological Survey of India (ASI) will launch the "Adopt a Heritage 2.0 Programme," the Indian Heritage App and e-permission portal on September 4, 2023, to preserve India's cultural heritage.

An Overview of the News

- ASI protects 3696 monuments across India, which showcase the country's rich cultural heritage and contribute to its economic development.
- ASI aims to enhance and maintain these heritage sites by launching the "Adopt a
 Heritage 2.0" program on 4th September 2023 at Samvet Auditorium, IGNCA, New Delhi.
 The revised program invites corporate stakeholders to use their CSR funds to enhance
 facilities at these monuments.

Program Overview:

- ASI's "Adopt a Heritage 2.0" program is a reimagined version of a scheme launched in 2017.
- It clearly outlines the specific features required for various monuments as per the AMASR Act 1958.
- Corporate Stakeholders A dedicated web portal: www. One can apply for the adoption of any monument or specific features through Indianheritage.gov.in.
- The portal provides details about monuments available for adoption, gap analysis and estimated financial requirements.

Importance of Cultural Heritage:

- Union Minister for Culture, Tourism and Development of North Eastern Region G Kishan Reddy emphasized the importance of cultural heritage in shaping India's identity.
- Heritage monuments are not just structures; They represent the history, art and architecture of India.
- The "Adopt a Heritage 2.0" program encourages corporate stakeholders to participate in preserving these monuments for future generations.

Selection Process:

- The selection process involves due diligence, discussions with various stakeholders, and assessment of economic and developmental opportunities at each monument.
- The selected stakeholders will be responsible for developing, providing, and maintaining facilities related to cleanliness, access, safety, and knowledge.
- Stakeholders adopting heritage sites will be recognized as responsible and heritagefriendly entities.
- The initial term of appointment will be five years, which is likely to be extended for another five years.

Indian Heritage Mobile App:

- ASI will launch a user-friendly mobile app called "Indian Heritage" on September 4, 2023.
- The app will showcase India's heritage monuments, including state-wise descriptions, photographs, a list of public facilities available, geo-tagged locations, and a feedback mechanism for citizens.
- The launch of the app will be in phases, starting with ticketed monuments in Phase I, followed by the rest of the monuments.

E-Permission Portal:

- An e-permission portal will also be launched, which will be available at www.asipermissionportal.gov.in.
- The portal streamlines the process of obtaining permission for photography, filming, and developmental projects at monuments.
- It aims to remove the operational and logistical hassles associated with obtaining various permissions.

10. Law Minister launches Tele-Law 2.0 (Sept. 2, 2023)

Union Minister Arjun Ram Meghwal launches Tele-Law 2.0 for legal advice.

Tele-Law 2.0:

The primary goal of the Tele-Law program is to positively impact the lives of one crore

• (ten million) beneficiaries by achieving this milestone well before the year 2026.

Tele-Law Programs:

- In 2017, the Tele-Law program was launched.
- The Department of Justice (DOJ) collaborated with the National Legal Services Authority (NALSA) and CSC e-Governance Service India Limited to facilitate the delivery of legal aid to the underprivileged population.
- The primary objective of this partnership was to ensure that marginalized communities have access to legal aid by leveraging Common Service Centers (CSCs).

Nyay Bandhu App:

- This app is part of Tele-Law 2.0, which combines Tele-Law services and the Nyaya Bandhu Android application.
- Its primary goal is to provide free legal guidance and representation to citizens.
- Nyay Bandhu (Pro Bono Legal Services) was started in 2017.
- The objective of this initiative is to establish a nationwide framework to provide free legal aid.
- "Pro bono legal services" means providing legal assistance voluntarily and without charge.
- The Latin phrase "pro bono" translates to "for free" in English.
