### **1. Operation Indravati Begins: Evacuation of Indian Citizens from Haiti ( March 23, 2024 )**

Operation Indravati was launched to evacuate Indian citizens from Haiti amid increasing gang violence.

#### **An Overview of the News**

- Armed gangs have attacked the suburbs of **Port-au-Prince**, prompting India to intervene.
- The evacuation plan includes relocating Indian nationals to the Dominican Republic.
- More than **15 Americans are being airlifted to Santo Domingo.**
- Haiti is facing a crisis exacerbated by gang violence following the **2010 earthquake.**
- Gangs are **carrying out attacks, burning police stations and spreading anarchy.**
- The airport was closed, prisoners were released, a state of emergency was declared, and a curfew was imposed.
- **Gang leader Jimmy Charizier** demanded the resignation of acting Prime Minister Ariel Henry. Ariel Henry announced his decision to step down but remained in power. Henry is currently in exile in Puerto Rico.

- Haiti, located in the Caribbean, shares the island of Hispaniola with the **Dominican Republic** to its east.
- Despite ongoing efforts to recover from the devastating 2010 earthquake, Haiti has preserved many sites dating back to the early 19th century.
- These sites include the **Citadelle La Ferriere**, which sits atop a mountain and serves as a fortress.
- The **Sans-Souci Palace**, the Baroque former royal residence of **King Henry I**, is located in nearby ruins, offering a glimpse of Haiti's historic past.

## **3. Union Minister Harsh Shanghvi grants Indian citizenship to 108 Pakistani migrants in Ahmedabad ( Sept. 12, 2023 )**

On September 12, 2023, in Ahmedabad, Union Minister Harsh Shanghvi provided citizenship to 108 migrants from Pakistan.

### **An Overview of the News**

- The right to grant Indian citizenship to minority communities from **Afghanistan, Bangladesh, and Pakistan** came through gazette notifications issued in **2016 and 2018.**
- The district collectors of Ahmedabad, Gandhinagar, and Kutch in Gujarat are empowered to follow the process under the Citizenship Act for granting Indian citizenship.
- Ahmedabad District Collectorate has already granted Indian citizenship to about **1,149 Pakistani** Hindu immigrants.

### **About Citizenship Act**

- Articles 5 to 11 under Part II of the Constitution address citizenship.
  - **Article 5** - Citizenship at the commencement of the Constitution
  - **Article 6** - Rights of citizenship of certain persons who have migrated to India from Pakistan

- **Article 7** - Rights of citizenship of certain migrants to Pakistan
- **Article 8** - Rights of citizenship of certain persons of Indian origin resident outside India
- **Article 9** - Persons who voluntarily acquire the citizenship of a foreign State not to be citizens
- **Article 10**- Continuance of rights of citizenship
- **Article 11**- Parliament shall regulate by law the right of citizenship
- The Constitution recognizes those persons who became citizens of India upon its commencement on January 26, 1950.
- It lacks detailed provisions for acquiring or losing citizenship after commencement.
- The Constitution gives Parliament the right to make laws in matters related to citizenship.
- **Parliament enacted the Citizenship Act (1955) as the primary legal framework for citizenship.**
- Amendments to the Citizenship Act, including the repeal of the Commonwealth citizenship provision, were made through legislative acts such as the **Citizenship (Amendment) Act of 2003.**

#### **4. India begins construction of world's highest combat airfield at Nyoma in Ladakh ( Sept. 11, 2023 )**

The Border Roads Organization (BRO) is building the world's highest combat airfield at Nyoma in Ladakh.

##### **An Overview of the News**

- Defense Minister Rajnath Singh will lay the foundation stone of this project at Devak Bridge in Jammu on September 12, 2023.
- Nyoma, a major village in southern Ladakh, already hosts an Indian Air Force base and an Advanced Landing Ground (ALG), established in 1962.
- The altitude of Nyoma reaches an impressive 4,180 meters (13,710 ft) above sea level, making it one of the highest altitudes in the region.

##### **Budget Allocation:**

- The Central Government has consistently increased its budget allocation for the development of border infrastructure.
- Last year, around ₹12,340 crore was allocated, underscoring the government's commitment to strengthening India's border infrastructure.

##### **Goals of India's infrastructure development:**

- Lieutenant General Rajiv Chaudhary, who heads the BRO, is optimistic about India's rapid progress in developing border infrastructure.
- India aims to surpass China in this regard on the 3,488 km long Line of Actual Control (LAC) within the next two to three years.

**5. GSV Vadodara and Airbus sign MoU ( Sept. 8, 2023 )**

Gati Shakti Vishwavidyalaya (GSV) Vadodara and Airbus signed an MoU for aerospace education and research. The aim is **to strengthen the Indian aviation sector through this partnership.**

**An Overview of the News**

- The MoU was signed by Rémi Maillard (President and Managing Director, Airbus India and South Asia) and Professor Manoj Chowdhary (Vice-Chancellor, Gati Shakti University).
- The signing ceremony was attended by Minister of Railways, Communications, Electronics and IT Ashwini Vaishnav, who also serves as the first Chancellor of Gati Shakti University.
- Jaya Verma Sinha, Chairperson and CEO, of the Railway Board and senior officials of the Railway Board, were also present.

**Airbus' commitment to India:**

**6. 'Gujarat Declaration' outlining the outcome of the first WHO Traditional Medicine Global Summit 2023 released ( Sept. 5, 2023 )**

The World Health Organization (WHO) released the outcome document of the first WHO Traditional Medicine Global Summit 2023 as the "Gujarat Declaration".

**An Overview of the News**

- The "Gujarat Manifesto" reaffirms the global commitment **to traditional medicine for health and wellness.**
- This emphasizes the need for rigorous scientific methods to understand and implement holistic and context-specific healthcare approaches.
- India, as the host of the WHO Global Center for Traditional Medicine in Gujarat, plays an important role in supporting Member States and taking forward the work agenda of the summit.

- **Key objectives** include enhancing evidence-based traditional complementary integrative medicine (TCIM), promoting standardized documentation, and establishing a global network of TCIM reference clinical centers.
- The declaration emphasizes leveraging digital health technologies, especially artificial intelligence, for digital resources related to TCIM.
- The summit was **organized by WHO** and **co-hosted by the Ministry of AYUSH in Gandhinagar, Gujarat on 17 - 18 August 2023.**

## **7. Rashtriya Chemicals & Fertilizers gets Navratna status ( Sept. 3, 2023 )**

On September 2, 2023, Rashtriya Chemicals and Fertilizers Limited (RCF) was conferred 'Navratna status' by the Department of Public Enterprises (DPE).

### **An Overview of the News**

- These companies have substantial financial freedom, which allows them to make investment decisions for projects up to a specific limit without requiring government approval.
- Navratna companies fall under the category of Central Public Sector Enterprises (CPSEs) and are evaluated based on specific operational and financial parameters, including factors such as net profit, total cost of production, earnings per share, and cross-sector performance.

**9. CM MK Stalin launches construction of South East Asia's largest desalination plant at Perur, Chennai ( Aug. 23, 2023 )**

- Development of Southeast Asia's largest desalination plant begins.
- Funding is provided by the Japan International Cooperation Agency (JICA).
- The project covers 85.51 acres of land, which is targeted to be completed by 2026.

**Innovative Water Treatment Technologies:**

- Advanced Methods: Dissolved Air Flotation and Dual Media Filtration.
- High-density polyethylene (HDPE) pipelines extend up to 1,150 meters into the sea.
- 59 km long drinking water pipeline up to Porur area.

- The 'Digi Yatra' initiative is a collaboration with the Ministry of Civil Aviation with the goal of modernizing and improving air travel.
