1. Indian Army inaugurates first ever two-storey 3-D printed dwelling unit in Ahmedabad (Dec. 29, 2022)

Indian Army inaugurates first ever two-storey 3-D printed dwelling unit in Ahmedabad

The **Indian Army** inaugurated its **first** <u>3-D Printed</u> **House Dwelling Unit** (with Ground plus One configuration) for soldiers at **Ahmedabad Cantt** on 28 December 2022.

Important facts

- The dwelling unit has been constructed by Military Engineering Services (MES) in association with MiCoB Pvt Ltd, incorporating the latest 3D Rapid Construction Technology.
- The **71 sqm dwelling unit** with **garage space** was completed in just 12 weeks using 3D printed foundations, walls and slabs.
- The disaster-resistant structures comply with **Zone-III earthquake** specifications and green building norms.
- The formation is a testimony to the commitment of the Indian Army in promoting the 'Atmanirbhar Bharat Abhiyan'.

About Technology

- This technique uses a solid 3D printer that accepts computerized three-dimensional designs.
- It builds up a 3-D structure in a layer-by-layer manner by extruding a specially designed special type of concrete.
- The Ahmedabad-based Golden **Katar Division of the Indian Army** has been instrumental in taking forward the project with manifold applications in operation.

What is 3D Printing?

- 3D printing uses computer aided design (CAD) to create three-dimensional objects through the layering method.
- The model to be printed with the help of software is first developed by the computer, which then instructs the 3D printer.

2. India grants permission to NEA to export additional 40 megawatts of electricity (Dec. 29, 2022)

Nepal Electricity Authority (NEA)

India has allowed the **Nepal Electricity Authority (NEA)** to export an additional **40 MW** of power from two more hydroelectric projects.

Important facts

- The **Central Electricity Authority of India** has approved the sale of surplus power from two more hydro projects **25 MW Kabeli B-1 and 20 MW Lower Modi** at competitive rates in the Indian energy market.
- With this, 452.6 MW of surplus power can be exported to India from 10 hydropower projects.
- NEA has stopped the export of surplus power to India from 19 December as generation from river-based hydroelectric power stations has reduced.
- NEA has generated a net income of **Rs 11.16 billion** by trading **1.36 billion units of surplus power** at a competitive rate in the Indian energy market till 18 December.
- The current electricity demand of Nepal stands at around **1,680 MW**, while the domestic production is **1,000 MW**.

- The launch of this portal is a major step towards bringing transparency and accountability in governance processes by leveraging technology.
- The online process will also save time and resources.
- Transfer of more than **5000 GDS** at a time has been approved through the online portal on the day of portal launch.

7. External Affairs Minister S. Jaishankar to visit Cyprus, Austria from December 29 to 3 January (Dec. 28, 2022)

External Affairs Minister S. Jaishankar to visit Cyprus, Austria from December 29 to 3 January

According to the Ministry of External Affairs, External Affairs Minister **S Jaishankar** will visit the Republic of Cyprus and Austria from December 29 to 3 January 2023.

Minister S.Jaishankar will be in the Republic of Cyprus from December 29 to December 31, 2022. This year marks **60 years of diplomatic relations between India and Cyprus.**

During his visit, Jaishankar will meet Cyprus foreign minister **loannis Kasoulides**. He will also address the Cyprus business and investment community and interact with the Indian diaspora.

Jaishankar visit to Austria

In Austria, the External affairs minister will meet Austrian Federal Minister for European and International Affairs, **Alexander Schallenberg**. This will be the first visit of an Indian foreign minister to Austria in the last 27 years. 2023 marks **75 years of diplomatic relations** between India and Austria.

S.Jaishankar will also meet the foreign ministers of Austria, Czech Republic foreign minister Jan **Lipavský** and Slovakia foreign minister **Rastislav Káčer** who will be there in the Austrian capital **Vienna** for the **Slavkov format meeting.**

Slavkov is a place in the Czech Republic. The Slavkov format was created in 2015. It is a cooperation format between **Austria**, **Slovakia**, **and the Czech Republic**.

During his visit, Jaishankar will call on Austrian **Chancellor Karl Nehammer**. He will also meet **Rafael Mariano Grossi**, Director General of the Vienna-based International Atomic Energy Agency (IAEA).

8. 1.53 lakh people died in 4.12 lakh road accidents in 2021: Ministry of Road Transport and Highways Report (Dec. 28, 2022)

Ministry of Road Transport and Highways Report

According to a report released by the Union Ministry of Road Transport and Highways on 28 December 2022 a total of 4,12,432 road accidents occurred in the 2021 calendar year which claimed 1,53,972 lives while 3,84,448 people were injured.

The report titled 'Road accidents in India — 2021', said major indicators related to accidents have performed better in 2021 when compared to 2019.

According to the report, "Road accidents decreased by 8.1 percent and injuries decreased by 14.8 percent in 2021 compared to 2019. Fatalities, however, on account of road accidents increased by 1.9 percent in 2021 corresponding to the same period in 2019,"

Not wearing seat belt and helmet a reason for road fatalities

- According to the report a total of 16,397 persons were killed in road accidents in 2021 due to not wearing seat belt, of which 8,438 were drivers and remaining 7,959 were passengers.
- A total of 46,593 persons were killed in road accidents due to not wearing a helmet, of which 32,877 were drivers and 13,716 were passengers.
- According to the report, not wearing a helmet caused injuries to 93,763 persons and not wearing seat belts caused injuries to 39,231 persons during 2021.
- Not using safety devices such as helmet and seat belt does not cause accidents but are critical for averting fatal and grievous injuries in the event of road accidents.
- Although not wearing a seat belt by passengers sitting in the rear seats attracts a fine of Rs 1,000 under Rule 138 (3) of the Central Motor Vehicle Rules (CMVR), most people are either unaware of this mandatory rule or just ignore it.

The country saw an unprecedented decrease in accidents, fatalities, and injuries. This was due to the outbreak of the COVID-19 pandemic and the resultant stringent nationwide lockdown particularly during March-April, 2020 followed by gradual unlocking and phasing out of the containment measures, it said.

The report is based on the data/information received from police departments of states/Union Territories collected on a calendar year basis in standardized formats as provided by the United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP) under the Asia Pacific Road Accident Data (APRAD) base project.

9. IOCL to help in the TB elimination effort of Uttar Pradesh and Chhattisgarh (Dec. 28, 2022)

IOCL to help in the TB elimination effort of Uttar Pradesh and Chhattisgarh

The government of India owned **Indian Oil Corporation Limited (IOCL)** has signed a Memorandum of Understanding (MoU) with the Central TB Division under the Ministry of Health and Family Welfare and the states of **Uttar Pradesh** and **Chhattisgarh** to undertake an intensified <u>TB elimination project</u>. This effort of the IOCL is part of its <u>Corporate Social Responsibility</u>.

The MoU was signed in presence of Union Minister of Health and Family Welfare **Dr. Mansukh Mandaviya** and Union Minister of Petroleum & Natural Gas and Housing & Urban Affairs, **Hardeep Singh Puri** in New Delhi on 28 December 2022.

According to the World Health Organisation **26% of** Tuberculosis (**TB**) **cases** in the world in 2020 was reported from India. Within India Uttar Pradesh and Chhattisgarh share the highest burden of TB cases among large states in India. The Indian Government has set a target to eliminate **TB in India by 2025.**

Indian Oil has emerged as the first corporate to supplement state efforts in Active Case Finding campaign (ACF) by investing close to Rs. 64 crore in all 75 districts of UP, covering approximately 10% of its population once a year for three years.

The Reserve Bank released its web publication entitled 'Statistical Tables relating to Banks in India: 2021-22' covering the activities of the Indian banking sector on 27 December.

Important facts

- The publication presents entity-wise information on major items of liabilities and assets along with their maturity profile, income and expenses, select financial ratios, number of employees, and details of priority sector advances for scheduled commercial banks excluding regional rural banks.
- In addition, capital-to-risk-weighted asset ratios, non-performing assets, exposure to sensitive sectors, contingent liabilities, and unclaimed deposits are included.
- State-wise distribution of consolidated balance sheet of rural cooperative banks are also presented.
