1. US Senate confirms Indian-American Richard Verma to top State Department post (April 2, 2023)

The **United States Senate** on March 30 confirmed the appointment of **Indian American Richard Verma** as **Deputy Secretary of State, Management and Resources**.

An overview of the news

- This position is normally seen as the **CEO of the powerful State Department in the US Government.**
- Richard Verma served as the **US Ambassador to India** from January 2015 to January 2017 and is currently the Chief Legal Officer and Head of Global Public Policy at **MasterCard.**
- He also served as **Assistant Secretary of State for Legislative Affairs** during the Obama administration.
- Prior to this he was **National Security Advisor to United States Senator Harry Reid.**
- Verma has also served as **Vice Chairman of The Asia Group**, Partner and Senior Counselor at Steptoe and Johnson LLP, and Senior Counselor at the Albright Stonebridge Group.
- Verma holds a BS degree from Lehigh University, an LLM with distinction from Georgetown University Law Center, and a PhD from Georgetown University.
- He was appointed to the President's Intelligence Advisory Board and he is a former member of the Weapons of Mass Destruction and Terrorism Commission.

10. Dilma Rousseff appointed as new President of BRICS New Development Bank (March 29, 2023)

Dilma Rousseff appointed as new President of BRICS New Development Bank

Former Brazilian President Dilma Rousseff has been elected as the new President of the New Development Bank (NDB), also known as the BRICS Bank.

An Overview of the News

- She replaced **Marcus Troyjo** as the President of NDB.
- Rousseff is an economist who served as the President of Brazil for two consecutive terms from January 2011 to August 2016.
- During her presidency, Rousseff prioritised social policies, including poverty reduction and increased access to education and healthcare.
- The NDB has so far approved \$23 billion in loans for projects including renewable energy and transportation infrastructure in its member countries.

About New Development Bank (NDB)

- It is a multilateral development bank established in 2014 by the BRICS countries Brazil, Russia, India, China and South Africa.
- It was created with the aim of **mobilising resources for infrastructure and sustainable development projects** in emerging economies.
- It is **headquartered in Shanghai, China** and has regional offices in **lohannesburg. South Africa and São Paulo. Brazil.**
- Its authorised **capital is \$100 billion**, with each founding member contributing **\$10 billion**.
- Its main focus is on **financing infrastructure projects** including **energy**, **transport and water supply**.
- It operates on the principle of "**co-ownership, governance and shared benefit**", which means that member states have equal representation and decision-making power.
- It is seen as an alternative to established financial institutions such as the **World Bank** and the International Monetary Fund, which are dominated by Western countries.
