1. New Liberation War Gallery Inaugurated at the Indian Cultural Centre in Dhaka (May 31, 2023)

On 30 May a new **Liberation War Gallery of 1971** was inaugurated at the **Indian Cultural Center of the Indian High Commission in Dhaka.**

An overview of the news

- Bangladesh Home Minister **Asaduzzaman Khan** was the chief guest on the occasion.
- India's High Commissioner to Bangladesh Pranay Verma joins **Home Minister in inauguration of Liberation War Gallery**
- The War Gallery houses some rare photographs of the **Liberation War of 1971**, which culminated in the liberation of then East Pakistan and its rise as the newest nation of South Asian countries.
- The inaugural program was attended by many freedom fighters, Bir Muktijodha, and distinguished guests, including many eminent personalities of Bangladesh, representatives of the cultural and educational fields of Bangladesh, and youth.
- The gallery displays heroic photographs and documents from the Bangladesh Liberation
 War of 1971 as a testament to the enduring bond of friendship between India and Bangladesh.
- It pays tribute to the brave freedom fighters who fought against oppression and tyranny.
- The gallery honors the memory of the unknown millions who laid down their lives during the **Liberation War of Bangladesh in 1971.**

Liberation War of 1971

- In the 1950s, Pakistan was ruled by a military-bureaucratic rule that ruled the entire **country (East and West Pakistan)** in an undemocratic manner.
- The Bengalites had no political representation in this system of governance.
- This dominance of West Pakistan was challenged by the Bengalis during the general elections of 1970.
- In the general election of 1970, the Awami League of East Pakistan's Sheikh Mujibur Rahman got a clear majority.
- West Pakistan was not ready for any leader of East Pakistan to rule the country.
- On **March 26, 1971**, West Pakistan launched Operation Searchlight in East Pakistan.
- As a result, lakhs of Bangladeshis had to take refuge in India.
- The Pakistani army had to face defeat due to the bravery of the 'Muktiwahini Sena' and Indian soldiers who fought for the independence of Bangladesh.

On 6 December 1971, a new nation Bangladesh was born out of 13 days of war with the intervention of India.

2. Kerala becomes India's first fully e-governed state (May 25, 2023)

3. More than 90% of funds allocated under Smart Cities Mission utilised (May 25, 2023)

Smart Cities Mission

Union Housing and Urban Affairs Minister **Hardeep Singh Puri** has announced that **more than 90%** of the funds allocated under the **Smart Cities Mission** are being **utilized and 73%** of the projects have already been completed.

An overview of the news

- The smart city project was to be completed within five years of the selection of the city.
- However, in 2021, the ministry changed the **deadline to June 2023** for all cities.

About Smart Cities Mission

- Smart Cities Mission is an initiative of the Union Ministry of Housing and Urban Affairs which was launched in 2015.
- It aims to transform urban areas into sustainable, citizen-friendly and technologically advanced cities.
- The mission's primary objective is to enhance the quality of life for citizens by providing them with improved infrastructure, better governance, and increased economic opportunities.
- Between **January 2016 and June 2018** (when the last city, Shillong, was selected), the ministry selected 100 cities for the mission in five rounds.

Selection Process

- The mission follows a competitive approach where cities submit proposals based on specific criteria, including the adoption of smart solutions, citizen engagement, and sustainable development.
- The selected cities undergo redevelopment in a phased manner.

Core components

- **Infrastructure development:** Emphasis is placed on developing physical infrastructure such as transportation systems, water supply, sanitation, and affordable housing to meet the needs of the urban population.
- **Technology integration**: The mission integrates technology to improve service delivery, including data analytics and smart grids devices for efficient resource management and real-time monitoring.
- **Citizen engagement:** The mission focuses on citizen participation and engagement through mobile applications and feedback mechanisms, empowering them to contribute to decision-making processes and hold authorities accountable.
- **Sustainable practices:** The mission promotes sustainable development by encouraging the use of renewable energy sources, green building practices, waste management systems, and efficient urban planning.

Funds Utilisation

- Till 1 May 2023, a total of **Rs 38,400 crore** was released for the Smart Cities Mission.
- Out of this amount, ₹35,261 crore has already been utilized for various projects.

Project Completion

- The Smart Cities Mission includes around **7,800 projects worth Rs 1.8 lakh crore.**
- Of these projects, more than **5,700 projects worth Rs 1.1 lakh crore** have been completed.
- The remaining projects are expected to be completed by June 30, 2024.
- Currently, only 22 out of 100 designated cities have successfully completed all the projects under the mission.

4. Maharashtra becomes the first state in the country to approve Good Governance Regulations (May 22, 2023)

Maharashtra-becomes-the-first-state-in-the-country-to-approve-Good-Governance-Regulations Maharashtra Chief Minister **Eknath Shinde** approved the **first Good Governance Regulations in the country.**

An Overview of the News

- The purpose of the rules is to enhance **accountability**, **accessibility**, **dynamism and transparency** in state administration.
- A separate cell will be set up to address the **effects of climate change.**
- The rules also include expanding the scope of 'Aaple Sarkar Seva Kendra' for end-toend online services to citizens within the prescribed time limit.
- Citizens' complaints will be redressed at a speedy pace.
- The chief minister's direction to develop the rules was given in **September last year.**
- The rules were drawn up in consultation with ministerial officials, experts and NGOs.
- **161 department-wise indices** have been prepared to evaluate the performance of good governance.

- CoE-SLM aims to promote South-South cooperation and address issues of land degradation through sustainable land management practices.
- Specific activities of the CoE-SLM include setting LDN targets, developing drought risk and early warning systems, mainstreaming gender considerations, promoting good governance of land rights and entitlements, and addressing the effects of land degradation on greenhouse gas emissions and biodiversity loss. involves assessing.
- Bhupendra Yadav released two publications during the inauguration: "Technical Paper on the Pathway to Achieving LDN in India" and "Compendium of Sustainable Land Management Practices."

Indian Council of Forestry Research and Education (ICFRE)

- The electronic bank guarantee system is accessible through **Baroda INSTA**, the **digital platform of Bank of Baroda**.
- The digital approach enhances **convenience**, **security and efficiency** in the issuance of inland bank guarantees.
- The system reduces manual paperwork, streamlines processes and promotes digital transformation in the banking sector.

About Bank of Baroda (BoB)

- It is an Indian public sector bank headquartered in Vadodara, Gujarat.
- It is the **second largest public sector bank in India** after **State Bank of India** and has a global presence with over 100 overseas offices.
- The bank was **established on 20 July 1908** by **Sayajirao Gaekwad III,** the **Maharaja of Baroda.**
- On 19 July 1969, the Government of India nationalised Bank of Baroda along with 13 other major commercial banks.
- After nationalisation, the bank became a profit making Public Sector Undertaking (PSU).

8. Ministry of Ports, Shipping and Waterways ranked 2nd on Data Governance Quality Index (May 13, 2023)

The Ministry of Ports, Shipping and Waterways (MoPSW) has been ranked second among 66 ministries in the Data Governance Quality Index (DGQI) assessment for the December quarter (Q3) of FY23.

An overview of the news

- The **ministry scored 4.7 out of 5**, indicating its commitment to excellence in data governance.
- Conducted by the Development Monitoring and Evaluation Office (DMEO),
 NITI Aayog, the DGQI survey aims to measure the maturity level of administrative data systems and their use in decision making of various ministries and departments on the implementation of central sector schemes.
- MoPSW's success in DGQI assessment was aided by the concerted efforts of the National Technology Center for Ports, Waterways and Coasts (NTCPWC) at IIT Madras,

which was tasked to improve MoPSW's Management Information System (MIS) in compliance with DGOI standards I went.

Six key indicators

The DGQI assessment covers six key themes including data generation, data quality, use
of technology, data analysis, access and dissemination, data security and human
resource capability, and case studies.

Data Governance Quality Index (DGQI)

- The Data Governance Quality Index (DGQI) survey is conducted by NITI Aayog's Development Monitoring and Evaluation Office.
- The survey aims to evaluate the performance of different Ministries /Departments in implementing Central Sector Schemes (CS) and Centrally Sponsored Schemes (CSS).

9. 1st Ministerial meeting of India-EU Trade and Technology Council (May 13, 2023)

The first ministerial meeting of the **India and the European Union Trade and Technology Council (TTC)** will be held in **Brussels** on 16 May.

An overview of the news

- The meeting will be co-chaired by the **Ministers of External Affairs**, Commerce and Industry and Communications, Electronics and Information Technology from the Indian side.
- India is only the second country after the US with which the European Union (EU) has a TTC, and the two sides agreed to launch the strategic mechanism during the visit of European Commission President Ursula von der Leyen to India in April 2022.
- The TTC aims to deepen trade and investment ties between India and the European Union, as well as foster greater cooperation on technology and innovation.

About India-EU Trade and Technology Council

 The trade and technology council was launched by Prime Minister Narendra Modi and European Commission President Ursula von der Leyen during Ms Leyen's visit to India in April 2022.
