Finland became the 31st member of NATO

**Finland** has become the **31st member of the North Atlantic Treaty Organization (NATO)** and Turkey's unanimous vote played a key role in Finland's acceptance as a NATO member.

#### **An Overview of the News**

- Finland shares a **border of more than 1,300 kilometres with Russia**, and their decision to join NATO was **based on security concerns** following Russia's invasion of Ukraine in 2022.
- Sweden's application to join NATO has been rejected by Turkey and Hungary.
- With the accession of Finland, NATO now includes countries in **most of Europe and North America.**

# 4. IMF approves 15.6 billion dollar support package for Ukraine ( April 1, 2023 )

The International Monetary Fund (IMF) has approved a \$15.6 billion support package to aid the economic recovery of conflict-torn country Ukraine.

#### An overview of the news

- The Russian invasion has devastated Ukraine's economy, causing **economic activity to shrink** by about **30 percent** last year, according to the IMF.
- War has destroyed capital stock and promoted poverty.
- The **48-month Extended Fund Facility program** approved by the **Fund's Board** amounts to approximately \$15.6 billion.
- It is part of the **IMF's \$115 billion** total support package, which includes debt relief, grants, and loans by multilateral and bilateral institutions.
- If the current conflict were to **continue into 2025**, it would raise Ukraine's financial needs from **\$115 billion to around \$140 billion**, said the IMF.

# 5. India's first quantum computing based telecom network link activated ( March 31, 2023 )

India's first quantum computing based telecom network link activated

The first quantum computing-based telecom network link has been activated in India and is located between Sanchar Bhawan and National Informatics Center (NIC) office at CGO Complex in New Delhi.

### **An Overview of the News**

- Telecom Network Link provides quantum secure communications, making it highly resistant to hacking attempts and cyber threats.
- Telecom Minister Ashwini Vaishnav inaugurated a small exhibition of quantum computing firms, inviting them to run pilot projects for communication networks and the Indian Railways.
- Using quantum computing, the telecommunications sector will benefit from faster and more secure communications, which can lead to improved network reliability and better user experiences.

# **About Quantum Computing**

- It uses qubits instead of classical bits to perform calculations, enabling it to perform calculations much faster than classical computers.
- Quantum computers use quantum-mechanical phenomena such as superposition and complexity to perform calculations.
- Potential applications of quantum computing include such revolutionary fields as cryptography, chemistry and materials science.
- Challenges facing quantum computing include the issue of qubit decoherence and the high cost of building and maintaining quantum computers.

# 6. Defense Ministry signs Rs 1700 crore contract with BrahMos Aerospace (March 31, 2023)

Defense Ministry signed a Rs 1,700 crore contract with BrahMos Aerospace Pvt Ltd (BAPL)

On March 30, 2023 The **Defense Ministry signed a Rs 1,700 crore contract with BrahMos Aerospace Pvt Ltd (BAPL)** for the procurement of next generation marine **mobile coastal batteries and BrahMos missiles.** 

### **An Overview of the News**

- The systems will be armed with **supersonic BrahMos missiles**, which are known for their **speed and accuracy.**
- The deliveries of these batteries are **scheduled to begin in 2027**, indicating that the Ministry of Defense is making long-term plans to strengthen its military capabilities.
- BAPL is a joint venture between India and Russia, highlighting the collaborative efforts of both countries in advancing defence technology.

### **About BrahMos Missile**

- BrahMos missiles are **medium-range ramjet supersonic cruise missiles** that can be launched from **submarines**, **ships**, **aircrafts or land**. **These missiles** are capable of travelling at a speed of Mach 2.8 and can carry conventional or nuclear warheads.
- Its **first successful launch took place on June 12, 2001**. The missile has undergone several successful tests and is considered one of the most reliable missiles in the world.
- It is named after **two rivers, the Brahmaputra of India and the Moskva of Russia**, symbolising the cooperation between the two countries in developing this technology.
- In 2016, India became a member of the Missile Technology Control Regime (MTCR), which aims to prevent the proliferation of missiles capable of carrying weapons

of mass destruction. India's entry into MTCR made it easier for India to **export BrahMos missiles to other countries which are members of MTCR.** 

# 7. UK signs deal to join trade pact with 11 Asia and Pacific nations ( March 31, 2023 )

**Britain** has signed a deal to join a trade deal with **11 Asia and Pacific countries** on 31 March 2023, three years after officially leaving the European Union.

#### An overview of the news

- According to the government's own estimates, joining the **bloc would increase the** size of the UK economy by only 0.08 per cent.
- The trade area covers a market of around **500 million people.**
- The UK said it is the **country's biggest post-Brexit trade deal** and is the **first European country** to join the CPTPP since it came into force in **2018**.
- The agreement is expected to be formally signed by the end of this year following approval by **Parliament and 11 member states.**
- The deal would cut tariffs on exports of **food**, **drink and cars**, **and provide access to a market of some 500 million people**.
- The UK will be worth 15% of global GDP once it joins the trade bloc.

# About Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP)

- It was established in 2018.
- It includes 11 countries Australia, Brunei, Canada, Chile, Japan, Malaysia, Mexico, New Zealand, Peru, Singapore and Vietnam.
- Membership of the CPTPP lowers restrictions on trade between members and also lowers customs duties on goods.

# 8. NGT slaps ₹10 crore penalty on Kerala government for failure to protect Ramsar sites ( March 31, 2023 )

NGT slaps ₹10 crore penalty on Kerala government for failure to protect Ramsar sites

The Principal Bench of the **National Green Tribunal (NGT)** in New Delhi has imposed a **fine of Rs 10 crore on the Kerala government** for failing to protect the **Vembanad and Ashtamudi lakes**, **listed as Ramsar sites**.

#### An overview of the news

- A principal bench headed by **Justice Adarsh Kumar Goel** said that as per the '**polluter pays principle'**, the fines imposed should be deposited in the ring-fenced account.
- The tribunal said that the amount to be utilized under the authority of the chief secretary should be employed for conservation or restoration measures.
- These wetlands have become polluted due to the **accumulation of pharmaceutical** waste, plastic waste, domestic waste and slaughterhouse waste.
- Vembanad, the largest wetland ecosystem in Kerala was designated as a Ramsar site in the year 2002.
- According to a study by the Kerala University of Fisheries and Ocean Studies, the water holding capacity and ecology of Vembanad Lake has decreased by 85% in the last 120 years due to encroachment and destruction.
- **Ashtamudi Lake** is home to many plant and bird species, which was included in the Ramsar list in August 2002.
- Presently there is a problem of waste accumulation at this site.

#### What are Wetlands?

- Wetlands are vital not only for the **ecosystems but our climate**, providing essential services such as **water regulation**, **flood control**, **and water purification**.
- Wetlands are also capable of absorbing carbon dioxide.
- Wetlands are called "Kidneys of the Earth".

#### What are Ramsar sites?

- A Ramsar site is a **wetland site** specifically designated for **international importance as a waterfowl habitat under the Ramsar Convention**.
- Ramsar Convention is an intergovernmental environment treaty established in 1975 by UNESCO.
- Ramsar refers to wetlands of international importance in terms of site ecology, botany, zoology or hydrology.

## **National Green Tribunal**

- It deals with cases relating to the **environment protection and conservation of forest**.
- It was set up in 2010 under the National Green Tribunal Act 2010.
- The Tribunal is not bound by the procedure laid down under the **Code of Civil Procedure**, **1908**, but is guided by principles of natural justice.

- New Delhi is the Principal Place of Sitting of the Tribunal and Bhopal, Pune,
- \* Kolkata and Chennai are other four places of sitting of the Tribunal.\

# 9. Unified rate approved for natural gas pipeline, new rate applicable from April 1 ( March 31, 2023 )

Unified rate approved for natural gas pipeline, new rate applicable from April 1

With the ambitious objective of **One Nation,One Grid and One Tariff**, the **Petroleum and Natural Gas Regulatory Board (PNGRB)** has decided to **change the Unified Tariff** which will be applicable from **1st April 2023.** 

### An overview of the news

- PNGRB has notified a **levelized Unified tariff of 73.93 rupees per MBTU (Metric Million British Thermal Unit)**.
- The rates will be implemented as **per three tariff zones** in the entire gas network of the country.
- This decision will give a boost to the **economic development** of all regions of the country.
- This will facilitate the government's vision for the development of gas markets and increase the utilization of gas in the country.

### Three different Tariff Zones

- The rate will be different for a **distance of 300 km** from the gas source.
- The rate will be different for the **distance of 300-1200 km** from the gas source.
- The area of more than 1200 km distance will come in the third zone.

## **National Gas Grid**

• It covers Indian Oil Corporation, ONGC, Gail India, Pipeline Infrastructure Limited, Gujarat State Petronet, Gujarat Gas Limited, Reliance Gas Pipeline, GSPL India Gasnet Limited and GSPL India Trans Limited.

## 10. Spouses of H-1B visa holders allowed to work in US (March 31, 2023)

Spouses of H-1B visa holders allowed to work in US

In a major relief to foreign workers in the US technology sector, a court there has ruled that the **spouses of H-1B visa holders can now work in the United States.** 

### An overview of the news

- The petition by 'Save Jobs USA' sought to quash the employment authorization cards given to the spouses of H-1B visa holders.
- Save Jobs USA is an organisation of IT workers who claim they lost their jobs because of H-1B workers.
- Tech companies like Amazon, Apple, Google and Microsoft opposed this petition.
- US District Judge Tanya Chutkan rejected the plea.
- The US has so far issued work rights to the spouses of **nearly 100,000 H-1B workers**, a sizable number of whom are Indians.

#### About H-1B Visa

- The H-1B visa is a **non-immigrant visa** that allows **US companies to employ foreign workers in specialty occupations.**
- It is designed to allow skilled foreign workers to come to the United States and work for American companies.
- This requires theoretical or technical expertise.
