1. President Murmu inaugurates Samvidhan Udyan in Jaipur (Jan. 3, 2023)

The President of India, **Droupadi Murmu** inaugurated **Samvidhan Udyan, Mayur Stambh, National Flag Post, statues of Mahatma Gandhi and Maharana Pratap at Raj Bhavan, Jaipur** on January 3, 2023.

Important facts

- On the occasion, she virtually inaugurated the Transmission System for Solar Power Sectors in Rajasthan and laid the foundation stone of the 1000 MW Bikaner Solar Power Project of SJVN Limited.
- The President said that women are continuously moving forward from Panchayat to Parliament House on their own.
- He said that it is a record to have more than **100 women in the Parliament** of the country for the first time.
- The President said that the framers of our Constitution crafted a comprehensive Constitution with sensitivity to each and every section of the society and awareness of each level of democracy and each aspect of governance.

2. RBI launches Utkarsh 2.0 for the period 2023-2025 (Dec. 31, 2022)

The Reserve Bank of India (RBI) Governor **Shaktikanta Das** on 30 December 2022 launched the second phase of the central bank's medium term strategy for strengthening regulatory and supervisory mechanisms called **Utkarsh 2.0.**

The **first strategy framework (Utkarsh 2022**) covering the period 2019-2022 was launched in July 2019. It became a medium-term strategy document guiding the Bank's progress towards realization of the identified milestones.

Utkarsh 2.0 like the Utkarsh 2022 has six Vision statements as well as Core Purpose, Values, and Mission statements. Collectively, they create a strategic guiding path.

The Vision in Utkarsh 2.0 that will guide the Reserve Bank of India over the period 2023-25 are:

- Excellence in performance of its statutory and other functions,
- Strengthened trust of citizens and Institutions in the RBI;
- Enhanced relevance and significance in national and global roles; Transparent, accountable and ethics-driven internal governance;
- Best-in-class and environment-friendly digital and physical infrastructure; and
- Innovative, dynamic and skilled human resources.

Reserve Bank of India (RBI)

Reserve Bank of India was set up under the Reserve Bank of India act 1934. It started functioning from **1 April 1935.**

It was **nationalized in 1949** and now the government of India is the owner of RBI.

Union Minister of State for Home Affairs **Nityanand Rai**, Director General of BSF **Pankaj Kumar Singh** were amongst those dignitaries present on the occasion.

Usefulness of the Prahari' app

Amit Shah said that the BSF 'Prahari' app is a great example of Proactive Governance. "Now jawans can get personal information and information related to accommodation, Ayushmann-CAPF and leaves on their mobiles. Be it GPF, Bio Data or grievance redressal on "Centralized Public Grievance Redress and Monitoring System" (CP-GRAMS) or information on various welfare schemes, now Jawans can get all this information through the app and this app will also connect them with the portal of the Ministry of Home Affairs."

The Union Home Minister also said that a "BSF Drone/UAV and Cyber Forensic Lab" has been set up in Noida, Uttar Pradesh through which captured drones of Pakistan have been thoroughly mapped for their linkages and locations across the border. These drones are used to bring narcotics and arms and ammunition to spread terrorism in India.

The **Border Security Force** was raised on 1 December 1965 after the India-Pakistan war of 1965. It is a border force which is deployed along the International border with **Bangladesh** and **Pakistan**.

BSF is also known as the nation's 'first **line of defence'.** It comes under the Union Ministry of Home Affairs.

He was speaking on 25 December 2022 at the '**Gwalior Gaurav Diwas'** function to mark the 98th birth anniversary of Atal Bihari Vajpayee. The event was also attended by Union ministers Jyotiraditya Scindia and Narendra Singh Tomar. Vajpayee was born in Gwalior on December 25, 1924.

The Madhya Pradesh government has allotted nearly 4,050 hectares of land in Sirol area of Gwalior to build a memorial of Vajpayee.

On the occasion, noted **sarod maestro Amjad Ali Khan**, eminent scientist Dr VK Saraswat, cardiologist Dr Jamal Yusuf, international hockey player Ishika Chowdhary and educationist OP Dixit were awarded the 'Gwalior Gaurav Samman', while renowned poet **Hariom Pawar** was presented the 'Atal Kavi Samman'.

6. Good Governance Day 2022 (Dec. 25, 2022)

Good Governance Day 2022

Every year **25 December** is observed as **Good Governance Day** to mark the birth anniversary of the 10th Prime Minister of India Atal Bihari Vajpayee. The day is celebrated so as to ensure that the citizens of the country are treated fairly by the government and the various government services shall be made available to them fairly.

The purpose of Good Governance Day is to increase public access to various government programmes and services via good governance. It was established with the slogan "Good Governance through e-Governance."

Background to the day

In 2014 the Prime Minister Narendra Modi announced that from now on 25 December will be observed as 'Good Governance Day' in the memory of the former Prime Minister Atal Bihari Vajpayee. Vajpayee was born on 25 December 1924 in Gwalior, Madhya Pradesh.

He has been the prime Minister of India three times.

He became the Prime Minister for the **first time** on 16 May 1996 and had to resign on 1 June 1996. He was the Prime Minister for the **second time** from 19 March 1998 – 13 October 1999.

He became the Prime Minister for the third time from 13 October 1999 - 22 May 2004.

Unique facts about Vajpayee

He was the first person to address the United Nations General Assembly (UNGA) in **Hindi**. As an External Affairs Minister he spoke in Hindi at the 32nd Session of the UNGA in 1977.

He also holds the distinction of being the prime minister of India for the shortest time, **16 days** in 1996.

He was the first Prime Minister against whom a no- confidence motion was passed in the Lok Sabha. He lost the no confidence vote by 1 vote in 1999.

He was awarded India's highest civilian award **Bharat Ratna** on 27 March 2015.
