# 1. WHO calls for intensified actions to eradicate Tuberculosis in South East Asia region ( March 25, 2023 )

On World Tuberculosis Day (24 March) the World Health Organisation (WHO) has called for intensified actions to eradicate the disease in the South East Asian region which bears the world's highest TB burden.

### An overview of the news

• WHO highlighted the urgent need to advance innovations, better address social and economic determinants, and improve multi-sectoral collaboration.

### TB burden in Southeast Asia

- In 2021, the region is expected to account for more than 45 percent of global TB incidence and more than half of global TB deaths.
- According to WHO, the COVID-19 crisis has exacerbated key social and economic determinants of TB such as poverty and malnutrition, pushing millions of people in the region into extreme poverty.
- An estimated 7 million additional TB cases and 1.5 million additional TB deaths could occur between 2022 and 2026 across the region.
- In 2022, the budget allocation for TB programs in the region is set to reach approximately US\$1.4 billion.

### World Health Organisation (WHO)

## 4. Anti-submarine craft INS Androth launched (March 24, 2023)

Anti-submarine craft INS Androth launched

The INS Androth, second in a series of eight Anti-Submarine Warfare Shallow Water Craft (ASW SWC), was launched in Kolkata on 21 March.

#### **About INS Androth**

- It is built by **Garden Reach Shipbuilders and Engineers (GRSE) Ltd** for the Indian Navy.
- It is 77.6 meters long and 10.5 meters wide.
- It is powered by **three diesel propellers**, these ships can reach a **top speed of 25 knots**.
- **Its primary Role** is to conduct anti-submarine operations in coastal waters, low-intensity maritime operations, and mine-laying operations.
- The first ship was delivered in December 2022.
- The contract for construction of eight ASW SWC vessels was signed on April 29, 2019.
- The commissioning of two ships of the same class within three months reinforces the Prime Minister's commitment to indigenous shipbuilding as part of the vision of 'Atmanirbhar Bharat'.

# 5. Amit Shah chairs regional conference on 'Drug Trafficking and National Security' in Bengaluru (March 24, 2023)

Amit Shah chairs regional conference on 'Drug Trafficking and National Security' in Bengaluru

Union Home Minister Amit Shah chaired the Regional Conference on 'Drug Trafficking and National Security' in Bengaluru on 24 March.

#### An overview of the news

- Representatives from **5 southern states and 3 union territories** participated in the conference.
- The Union Home Minister also supervised the **destruction of 9,298 kg of seized narcotics worth Rs 1,235 crore** during the meeting.
- The Home Minister focused on aspects such as zero tolerance in the regional conference on ways to reduce drug trafficking through sea routes and consequential stringent punitive action on drug traffickers.

### **Drug addiction in India**

- India is situated between the **world's two largest opium producing regions** (the 'Golden Triangle' on one side and the 'Golden Crescent' on the other).
- The 'Golden Triangle' region includes Thailand, Myanmar, Vietnam and Laos.
- The 'Golden Crescent' region includes Pakistan, Afghanistan and Iran.
- According to the World Drug Report 2021, prescription drugs and their ingredients are increasingly being converted into recreational use in India (the world's largest producer of generic drugs).
- India is also linked to shipments of drugs sold in the **19 major darknet markets** analysed in **2011-2020.**
- According to the report released by the Ministry of Social Justice and All India Institute of Medical Sciences (AIIMS) on the quantum of substance abuse in 2019.
- There are 31 million cannabis users in India (of which 2.5 million were dependent users).
- There are 23 million opioid users in India (of which 2.8 million were dependent users).

The annual bilateral maritime exercise 'Konkan' between the Indian Navy and UK's Royal Navy was held off the Konkan coast in the Arabian Sea from March 20-22.

# An overview of the news

- The joint exercise by both the navies demonstrated operational **readiness**, **enhanced interoperability and improved capability to conduct joint operations**.
- **INS Trishul**, a Guided Missile Frigate, and **HMS Lancaster**, a Type 23 Guided Missile Frigate, participated in 'Konkan 2023' and conducted several maritime exercises to enhance interoperability and imbibe best practices.
- The exercise covered all domains of maritime operations, air, surface and subsurface.
- India and the UK agreed on new cooperation on maritime domain awareness, including new agreements on maritime information sharing,
- The UK has been invited to join India's Information Fusion Center in Gurugram.

#### About 'Konkan' exercise

- It is a **bilateral naval exercise** conducted between **India and the United Kingdom.**
- The Konkan series of exercises was started in 2004.
- Since then, the exercise is conducted by both the navies in rotation.
- The exercise provided excellent training to the personnel of both the navies.

## 9. Interpol withdraws Red Notice against Mehul Choksi (March 23, 2023)

Interpol has withdrawn the Red Corner Notice (RCN)

Interpol has withdrawn the Red Corner Notice (RCN) issued against Mehul Choksi, the main accused in the Rs 13,500 crore PNB loan scam case.

#### An overview of the news

• Central Bureau of Investigation (CBI) has sought the restoration of the notice.

## **Case against Mehul Choksi**

- Mehul Choksi is the owner of Gitanjali Group, a jewelery firm with 4,000 stores in India.
- He along with his nephew **Nirav Modi** is a culprit in the **Rs 13,500 crore Punjab National Bank (PNB) scam.**
- Choksi and Modi are accused of issuing fake Letters of Undertaking (LoU) and foreign letters of credit to companies owned by them in connivance with bank officials.
- In this case, PNB did not keep any security before issuing the LoU.
- The matter came to light in **January 2018**, when PNB submitted a fraud report to the Reserve Bank of India.
- The CBI registered an FIR in the matter a week later. By this time Choksi had fled the country.
- Choksi is wanted in India on charges of **criminal conspiracy**, **criminal conspiracy**, **cheating and financial embezzlement**.

## What is an Interpol Red Notice?

- Criminals or suspects often flee to other countries to escape justice.
- A Red Corner Notice, or Red Notice (RN), alerts police forces around the world to **fugitives who are wanted internationally.**
- A Red Notice is a request to law enforcement around the world to locate and temporarily arrest a person wanted for **extradition**, **surrender or legal action**.
- A Red Notice is **not an international arrest warrant.**

## **About Interpol**

- The full name of INTERPOL is the **International Criminal Police Organisation** and is an intergovernmental organisation.
- It was **set up in 1923.**
- Member countries 195
- India became its member on 15 October 1949.
- It helps police in all of them to work together to make the world a safer place.
- Headquarter Lyon, France.
- Different Notices of Interpol Red Notice, Green Notice, Yellow Notice, Orange Notice, Blue Notice, Purple Notice, Black Notice, and an INTERPOL-UN Security Council Special Notice.
- Its work focuses on public safety and combating **terrorism**, **crimes against** humanity, genocide, war crimes, environmental crimes, etc.

# 10. Gujarat court sentences Congress leader Rahul Gandhi to two years in jail ( March 23, 2023 )

A court in Surat in Gujarat has convicted Congress leader Rahul Gandhi in a criminal defamation case filed in 2019 over his remarks on Modi's surname.

### An overview of the news

- The court also sentenced him to two years in jail.
- The court of **Chief Judicial Magistrate HH Verma** convicted **Rahul Gandhi under** sections 499 and 500 of the Indian Penal Code.
- The court granted bail to Rahul Gandhi and stayed the sentence for **30 days so that** he can appeal in a higher court during this period.
- After this decision, Rahul Gandhi's membership of Parliament can also go from Wayanad parliamentary constituency.

Before the 2019 Lok Sabha elections, Rahul Gandhi made an objectionable

• comment on the Modi surname while addressing a public meeting in Kollar, Karnataka.

#### What will be the effect of this decision?

- The disqualification of an MP convicted of an offense can be in **two cases.**
- If the offense for which he is convicted is listed in **section 8(1) of the Representation of the People Act, 1951**. This includes offenses such as section **153A** (offence of promoting enmity between different groups on grounds of religion, race, place of birth, residence, language, etc. and doing acts prejudicial to maintenance of harmony) or section 171E (offence of bribery). Are.
- **Section 171F** (offence of undue influence or impersonation at election) and certain others.
- **Second, Section 8(3**) of the RPA states that an MP can be disqualified if convicted and sentenced to a minimum of 2 years' imprisonment.
- However, the section also states that disqualification takes effect only "**after the lapse of three months**" from the date of conviction.
- Within that period, Gandhi can file an **appeal against the conviction before the High Court.**
